Secure shredding with unrivalled service

Whether your confidential material is in the form of paper records, digital media, uniforms, ID badges or other items, our secure process ensures that all materials and data are strictly contained and controlled.

Confidential data and materials are collected by uniformed and security-vetted staff, in a range of satellitetracked and secure vehicles. The data is returned to one of our destruction centres, where it is unloaded inside a high security warehouse and shredded on the same day. All suitable shredded paper material is then baled and sent to a paper mill to be recycled into paper or tissue products, depending on the grade.

Off-site secure shredding process

- Confidential material is placed in lockable containers on your site
- Our collection vehicle visits your site
- The material is taken to our secure destruction site and shredded
- A Certificate of Destruction is issued to you
- All shredded paper is taken to a paper mill and recycled
- New paper is produced which you can buy to close the recycling loop
